

PB Cabinets Privacy Policy

This Privacy Policy explains how we collect, use, and disclose Personal Information when you use our Service. By using our Service, you agree to the collection and use of information as described in this Privacy Policy.

Information Collection and Use

We may ask you to provide certain personally identifiable information that can be used to contact or identify you ("Personal Information") while using our Service. Personal Information may include your email address, name, and other relevant details.

We collect this information to provide you with the best service experience possible and for our internal business purposes that are part of our normal business practices. Some personal information is optional, but not providing certain types of personal information may limit the functionality of the Service.

Analytics Information

We utilize third-party analytics tools to measure traffic and usage trends for the Service. Log Data

When you visit our Service, we collect information that your browser sends us ("Log Data"). This Log Data may include your computer's Internet Protocol ("IP") address, browser type, browser version, the pages of our Service that you visit, the time and date of your visit, the time spent on those pages, and other statistics. If you access the Service through a mobile device, we may also collect certain information automatically, such as the type of mobile device you use, your mobile device's unique ID, the IP address of your mobile device, your mobile operating system, the type of mobile Internet browser you use, and other relevant statistics.

Location Information

With your permission, we may use and store information about your location to provide features and improve customization of our Service. You can enable or disable location services at any time through your device settings.

Cookies

We use "cookies," which are small files with unique identifiers that are sent to your browser from our website and stored on your computer's hard drive. These cookies collect information to enhance your experience. You can instruct your browser to refuse all cookies or to indicate when a cookie is being sent. However, if you do not accept cookies, some parts of our Service may not function properly.

Service Providers

We may engage third-party companies and individuals to assist us in providing and analysing our Service. These entities have access to your Personal Information only for the purpose of performing these tasks on our behalf and are obligated not to disclose or use it for any other purpose.

Security

While we strive to use commercially acceptable means to protect your Personal Information, please be aware that no method of transmission over the Internet or electronic storage is 100% secure. We cannot guarantee absolute security, but we implement reasonable measures to safeguard your information.

International Data Transfer

Your information, including Personal Information, may be transferred to and maintained on computers located outside your jurisdiction. If you are located outside Australia and choose to provide information to us, please note that we transfer and process the information in Australia. By submitting your information, you consent to this transfer.

Access and Correction

Under Australian Privacy Principle 6 of the Privacy Act 1988 (Cth), you have the right to access and correct the personal information we hold about you in certain circumstances. If you would like to obtain such access or make corrections, please contact us using the details provided above. Please note that this Privacy Policy does not replace other legal procedures for accessing or correcting personal information, including those under the Freedom of Information Act 1982 (Cth).

Complaints

If you believe there has been a breach of privacy, you may lodge a complaint under Australian Privacy Principle 1 of the Privacy Act 1988 (Cth). To submit a complaint, please contact us using the details above and include your name, address, details of the alleged breach, and a URL link if applicable. We will investigate your complaint within 30 days and work towards resolving the issue.

Retention of Information

We retain information for as long as necessary or permitted, but we do not have specific retention obligations. We may dispose of information in our discretion, subject to applicable laws. It is your responsibility to maintain your own backup records.

Links to Other Sites

Our Service may contain links to third-party sites that are not operated by us. We recommend reviewing the Privacy Policy of every site you visit, as we have no control over their content, privacy policies, or practices.

Children's Privacy

Our Service is not intended for children under the age of 18 ("Children"). We do not knowingly collect personally identifiable information from children under 18.
